I have full knowledge, understanding, and appreciation of risks and dangers of accidental harm which are involved in participating as a volunteer for the Event, or related functions, either in the planning and organizational stages, at the Event, or otherwise volunteering with the Organizer and I voluntarily assume these risks. I acknowledge that I have willingly chosen to participate and volunteer at the Event.

In consideration of the acceptance of me as a volunteer and permitting me to participate as such, I agree to save harmless and keep indemnified the Organizer, Sponsors, directors, employees, cooperating organizations and their respective officers, agents, or any other parties connected with this Event in any way singly or collectively, from and against any blame, liability, claims, costs or cause of action which may result from or arise out of my participation in the Event, including but not limited to death, injury, harm, monetary loss, inconvenience or damage of any kind or nature that may occur as a result of my participation in the Event, however caused.

Volunteers shall not at any time or in any manner divulge, disclose or communicate any other information deemed confidential, material, or important to the Festival without the written permission of the Festival and the Board of Directors. Any breach of the foregoing may adversely affect the business of the Festival, its effective and successful management, and its inherent good will. Furthermore, any information, improvements or ideas made or conceived by the individuals as Volunteers shall be the property of the Festival.*

I acknowledge that I have read, and agree to follow the Organizer’s Code of Conduct attached as Appendix “A” hereto, and that it is my responsibility to act in such a manner as required.

**Code of Conduct**

- Volunteers must avoid all situations in which their personal interests conflict or might conflict with duties to the Festival. If a conflict arises, it must be immediately reported to us via [email](mailto:volunteercoordinator@festival-of-trees.com).
- Volunteers must maintain confidentiality of any information learned and/or contributed as a result of their service
- Any breach of the code of conduct will be sufficient grounds for disciplinary action up to and including termination of the individual from the volunteer position
